CALIFORNIA STATISTICS - CONSUMER CASE INFORMATION

This report details the disposition of cases received by the Construction Arbitration Program for Homes (CAP-Home). All cases are arbitrations, CAP-Home does not administer mediation.

While some cases are by private agreements, most CAP-Home cases fall under the terms of a builder supplied warranty, which contains an arbitration clause. As such, these parties are demanding arbitration pursuant to a pre-dispute arbitration clause.

The nature of these disputes is residential construction.

In all instances, the parties are not required to use CAP-Home as the private arbitration company.

If known by CAP-Home Administration, this report includes the amount of the claim, whether equitable relief was requested or awarded, the amount of any monetary award, the amount of any attorney's fees awarded, and any other relief granted. If this information is not listed, it is because this was not reported and therefore not known by CAP-Home Administration. This is often the situation in disputes covered by warranty where the warrantor is expected to bring the product into compliance with established standards, rather than fulfill a monetary settlement.
